Open Houses

If planning on renting or selling your home, guidelines for Open Houses are as follows:

- * A notice shall be sent to the community manager at least seventy-hours (72) before the scheduled date.
- * No more than five (5) directional signs can be placed.
- * Signs can only be placed on common areas.
- * Signs may not be placed on owner lots.
- * The signs may be placed up to one hour before the event and must be removed no later than one hour after the event.

For Rent / Sale Signs

Only community-approved For Rent or Sale signs can be placed on the owner's lot. A DRB Modification Application needs to be submitted for approval prior to installing the sign.

Loose Dogs

It's been reported that residents are walking their dogs without a leash or unattended, attacking other dogs and residents. When an incident happens, the person it happened to needs to contact Animal Services Osceola County directly to report it. They do not take complaints from third (3rd) parties.

- * 1st complaint: they visit the home and educate them about the county's & city's ordinances.
- * If they get a 2nd or more complaint about the same dog(s) within one (1) month of the original complaint, they visit the home for a citation. Evidence is required (videos and/or photos).
- * If they get a 2nd or more complaint about the same dog(s) one (1) month after of the original complaint, a new complaint is filed and they start the process again.
- * Complaints are public records.

Lightning Rules at The Pool.

Pool activities should remain suspended until thirty minutes after the last thunder is heard. The distance from Strike A to Strike B to Strike C can be some 5-8 miles away. And it can strike much farther away. Why take a chance with lightning?

Guest Policies

- Guest must be accompanied by a Resident or Renter at all times while using the AmenityCenter.
- Resident Or Renter may accompany no more than four (4) guest per household to the Amenity Center.
- Residents or Renters are responsible for any and all actions taken by such Guest.

Community Friendly Reminders

- **Community Ponds** The ponds in the community are retention ponds. No swimming, fishing or boating is allowed.
- Street Parking The Tohoqua Master Association kindly asks you to be courteous of your neighbors and park your cars in your garage or on your driveway and do not block sidewalks. This applies for the residents and visitors.
- Trash Cans As stated in the Design Review Manual, "all trash containers must be stored in the rear yard or garage and out of view of the street on non-collection days. Garbage cans and trash containers shall not be placed outside the home for pick-up earlier than 7:00pm on the day preceding the pick-up and shall be removed the day of pick-up". Please discontinue leaving the trash receptacles in public view on non-collection days and follow the schedule as stated in the community declaration. Also, trash cans cannot be placed directly in the crosswalks, in the pedestrian path ways. friendly reminder, trash pickup days are:

Tuesdays: Trash (Brown)
Wednesdays: Yard (Green)
Fridays: Recycling (Blue)

Lock Box - In need to make an assessment or event payment or submit a DRB
 Application and can't make it to the onsite management office? For your convenience, a lock box was installed in the fit

ness center which opens daily from 4:30 am until 11:00 pm.



• Community/Builder Dumpsters -

Residents may NOT use the community/builder dumpsters for their bulk trash. This includes any building materials from resident contractors.

Please be advised that this is considered illegal dumping and is punishable by law. Under Florida State Statute 403.413, it is illegal to dump, discard, place, throw, dispose, or deposit any rubbish, waste, or trash onto any property (private or public) without consent. Fines associated with Felony Littering can cost an offender anywhere between \$100 - \$500.
